### Activity Scope: Small Structural/Misc./Plate Steel Fabricator

#### Scope Criteria

A firm or corporation which is recognized as a small structural steel, miscellaneous, steel plate fabricator or erector with a plant/office located and working within Canada with gross worldwide sales (direct or subcontracted) of less \$3 million dollars (CDN). Companies with gross sales higher than \$3MM do not qualify as Associates and are to fill in the CISC Member Application. Companies that are brokers of fabricated steel are not eligible.

Note 1: a company meeting these criteria may wish to apply as a CISC Member to take advantage of various benefits available only to Members (some conditions apply).

Note 2: gross sales are your total of fabrication and erection of steel work subcontracted or completed by your own personnel and/or equipment. This also includes fabrication sent to the U.S. if applicable. It excludes any rebar, warehouse type sales, and erection subcontracts for work in the United States.
